## **CBP Boston Field Office Facilities (FOF)**

- Ten (10) Land Ports of Entry (LPOEs) in the Boston Field Office (BFO) have been selected for renovation or complete redesign and rebuild; two more in the New York Field Office.
- BFO has received over \$530 million in congressionally appropriated funds to support this effort across the country.
- GSA's New England Region has received \$530 million in BIL (Bipartisan Infrastructure Law) funds for these ten projects.
- Currently in preliminary design, moving into conceptual design.





### New York & Vermont BIL LPOEs







## Inflation Reduction Act (IRA)

- GSA's New England Region has approximately \$154M available to incorporate Low-Embodied Carbon (LEC) materials in BIL projects.
  - Concrete
    Glass
  - Steel Asphalt
- Funds must be obligated by September 30, 2026.
